

**COLLINGWOOD SKI CLUB**  
**COVID-19- ASSUMPTION OF RISK, DECLARATION AND RELEASE**

The Collingwood Ski Club (the “Club”) is implementing a number of preventative protocols (“COVID-19 Protocols”) provided by the Government of Ontario and Grey Bruce Public Health with a view to reducing the spread of COVID-19 in the Club. The Club’s COVID-19 Protocols are available for your review in advance of completing this form. It is imperative that each member agrees to observe and fully abide by all of the COVID-19 Protocols when using the Club facilities.

Despite all efforts made to minimize risk of spread of COVID-19, the Club cannot guarantee that you will not become infected with COVID-19 as a result of your use of the Club facilities. Moreover, attending the Club and using its facilities could increase your risk of contracting COVID-19. This is a risk that each guest must assess themselves when deciding to visit the Club.

**1. Assumption of Risk and Release** - You acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you may be exposed to or infected by COVID-19 by attending and/or participating in activities at the Club. Moreover, you hereby forever release and discharge the Club, along with its officers, directors, managers, employees, members and other representatives, and their successors and assigns (collectively, the “Club Representatives”), from any and all claims of whatever kind or nature, as a result of entering the Club and/or utilizing the Club facilities.

**2. Health Declaration** – You hereby declare that neither you nor anyone in your household has experienced any cold or flu-like symptoms in the last 14 days (to include fever, cough, sore throat, respiratory illness, difficulty breathing).

**3. Health Declaration** – Further Assurances - In the case that you or anyone in your household experiences any cold or flu-like symptoms or receive a positive COVID-19 test result after submitting this declaration and having entered into the Club, you agree:

(a) To immediately inform the Club; and

(b) To not enter the Club,

(i) In the case of a positive COVID-19 test result, until 14 days after receiving a negative COVID-19 test result; or

(ii) In the case of cold or flu-like symptoms, until 14 days after the cold or flu-like symptoms have ceased.

**4. Travel Declaration** - You hereby declare that neither you nor any member of your household have travelled to or had a lay-over in any country outside Canada in the past 14 days. If you or anyone in your household travel to any country outside Canada after submitting this declaration, you will then not visit the Club for a minimum period of 14 days after the date of return to Canada.

**5. Compliance with COVID-19 Protocols** – You hereby agree to comply with the COVID-19 Protocols set out by the Club and that any failure to comply therewith could result in refusal of your access to the Club.
